Now on this 28 day of June 2021, came on before this Court detainee BENSON, KAREN LYNN for her first appearance.

The Detainee was informed of the charge and informed of the following rights:

- To be represented by an attorney and that a free attorney would be appointed if the detainee cannot afford one.
- That the detainee is not required to say anything and that anything the detainee says can be used against her.
- That the detainee has a right to communicate with her counsel, her family or her friends and that reasonable means will be provided for him to do so.

The Court finds that the defendant IS IS NOT Indigent and, if an indigency finding is made, the public defender's office is hereby appointed.

The Court made a determination that there is/is not probable cause for detaining the detainee;

OR

A probable cause determination has previously been made.

After conducting a pretrial release inquiry pursuant to ARK. Rule Crim. Pro. 8.5, the Court hereby fixes bond in the amount of \$ \$ 50,000.00 cash or corporate surety.

The detainee's release will be conditioned on obeying all laws, having no arrests, maintaining good contact with her attorney, attending all court appearances, obeying all court orders from all courts, and (if checked) on the detainee's having NO CONTACT with:

It appears there exists a danger that the detainee will commit a serious crime or will seek to intimidate witnesses or will otherwise unlawfully interfere with the orderly administration of justice, and the detainee is:

required to report regularly to and remain under the supervision of an officer of the court.

prohibited from going about the following premises _____

prohibited from possessing any dangerous weapon and/or consuming alcohol or illegal drugs.

The detainee is ordered to appear for arraignment on the 26 day of July 2021 at 07:45 in the courtroom at the Washington County Detention Center, 1155 W Clydesdale Dr, Fayetteville, Arkansas, and the detainee was advised that failure to appear at said hearing will constitute the separate offense of Failure to Appear, a crime punishable by a fine and/or jail sentence.

In the light of the global COVID-19 pandemic and pursuant to Arkansas Rules of Criminal Procedure 28.1(a) and 28.3(h), the Court finds speedy trial, the nine month rule, and revocation hearing timelines are tolled from the date of this Order until the next scheduled court date.
